### **Unions Set the Agenda in Sacramento**

In 2006, working people in California achieved a remarkable series of victories. Unions set the agenda for the year with an overwhelming defeat of Governor Schwarzenegger's anti-union ballot measures in the Special Election. The Governor would not have agreed to new gains for working people if unions hadn't exposed his record on those issues to California voters.

In one of the most significant legislative gains in years, labor won a minimum wage increase of \$1.25 over two years. AB 1835 (Lieber) raises California's minimum wage to \$8 by 2008, making it one of the highest minimum wages in the country.

Hot on the heels of the wage raise, we won a major victory in the creation of a discount program that will benefit millions of Californians who are unable to afford prescription drugs. AB 2911 (Nuñez) allows the state to use the purchasing power of Medi-Cal to help obtain discounts for low-income Californians. It's estimated that the legislation will result in average discounts of 40 to 60 percent.

In another critical win for union members in 2006, we preserved the right to see our own doctors if we get injured on the job. AB 2068 (Nava) extended until December 21, 2009 the right of union members to predesignate our doctors.

In a remarkable testament to labor's ability in the Capitol, the Federation and our unions also defeated AB 2399 (Garcia), a tribal-state gaming compact that lacked protections for workers who seek a voice at work and a good union contract.

In a bow to his corporate donors, Schwarzenegger vetoed legislation that would have restored permanent disability benefits for injured workers that he slashed two years earlier. And he again vetoed bills to disclose the list of corporations, like Wal-Mart, that rely on taxpayer-funded healthcare programs for their employees, to assess the economic impact of retail superstores on our communities, and to help curb corporate tax evasion in the manner of Enron and WorldCom.

The Governor also refused to sign legislation to prevent abuse of the state's out-of-control initiative process.

Overall, however, the year brought several major advances for working people in California. The year was a testament to the continued activism of organized labor to improve the lives of workers across the state.

### **Key Labor Bills**

#### **ASSEMBLY:**

- Corporate Tax Honesty (AB 675 Klehs). Would have required corporations to disclose the differences between how much profit they report to their shareholders and how much they report to the state tax board. Passed Senate Floor 23-15 on 08/16/06; Passed Assembly Floor 46-32 on 8/21/06. VETOED.
- Cell Phone Cancellation Rights (AB 1010 -Ruskin). Would have restored the right of cell phone users to have 21 days to cancel new or renewed service before a company can impose early termination penalties. Passed Senate Floor 23-16 on 8/28/06; FAILED Assembly Floor 36-36 on 8/31/06.
- Public Employee Collective Bargaining (AB 1369

   Nuñez). Memorandum of Understanding to ratify contract of state employees represented by SEIU Local 1000. Passed Senate Floor 29-8 on 8/21/2006; Passed Assembly Floor 58-20 on 8/24/2006. SIGNED.
- Minimum Wage Increase (AB 1835 Lieber). Raises the state minimum wage from \$6.75 to \$7.50 on January 1, 2007 and then to \$8.00 on January 1, 2008. Passed Senate Floor 25-13 on 8/30/06; Passed Assembly Floor 50-28 on 8/31/06. SIGNED.
- Health Care Disclosure Act (AB 1840 J. Horton). Would have required a report to the Legislature with the names of corporations in California that have 25 or more employees receiving healthcare benefits from the Healthy Families or Medi-Cal programs. Passed Senate Floor 22-15 on 8/23/06; Passed Assembly Floor 48-30 on 8/28/06. VETOED.
- Proof of Workers' Compensation Insurance Coverage (AB 1883 - De La Torre). Would have created a public access database of employers' workers' compensation insurers. Passed Senate Floor 24-15 on 08/28/2006; Passed Assembly Floor 47-30 on 8/29/2006. VETOED.

- Unemployment Benefits for Locked-Out Workers (AB 1884 - Chu). Would have ensured that workers who are locked out during a labor dispute through no fault of their own are eligible for unemployment benefits. Passed Assembly Floor on 5/31/2006 44-35; Passed Senate Floor 23-15 on 8/16/2006. VETOED.
- 8. Workers' Right to See Own Doctor (AB 2068 Nava). Maintains, until December 21, 2009, the right of injured workers to pre-designate their treating physicians and see their own doctors should they get injured on the job. Passed Assembly Floor 51-27 on 8/30/2006; Passed Senate Floor 28-9 on 8/29/2006. SIGNED.
- Unemployment Benefits for Locked-Out Workers (AB 2209 - Pavley). Would have entitled otherwise eligible employees to unemployment insurance benefits in instances where an employer has engaged in specified illegal activities during a lockout. Passed Assembly Floor 47-33 on 5/31/2006; Passed Senate Floor 23-15 on 8/16/2006. VETOED.
- Court Interpreter Commission (AB 2227 Chu). Would have established an appointed commission to advise and report to the Legislature and Judicial Council regarding court interpreter issues. Passed Assembly Floor 48-22 on 5/25/2006; Passed Senate Floor 25-15 on 8/17/2006. VETOED.
- 11. Farm Labor Contractor Disclosure (AB 2327 -Arambula). Would have required farm labor contractors to disclose in the itemized pay stubs furnished to employees the name and address of the legal entity that hired them. Passed Senate Floor 24-15 on 8/17/2006; Passed Assembly Floor 44-34 on 8/21/2006. VETOED.

- 12. **CSU Employee Retirement** (AB 2355 Negrete McLeod). Would have allowed California State University academic employees to purchase retirement credits for time spent on reduced time leave and required the employer to contribute the amount that would have been contributed if the member was not on reduced time leave. Passed Senate Floor 22-15 on 8/24/2006; Passed Assembly Floor 48-31 on 8/31/2006. VETOED.
- Agua Caliente Compact (AB 2399 Garcia). Would have ratified a tribal-state gaming compact that did not include enforceable protections to allow tribal casino workers to join a union and collectively bargain. BAD BILL. FAILED Assembly Floor 36-23 on 8/31/2006.
- Lower Prescription Drug Prices (AB 2911 Nuñez/ Perata). Creates a drug discount program that will benefit millions of Californians who are unable to afford prescription drugs. Passed Senate Floor 25-12 on 8/29/2006; Passed Assembly Floor 47-31 on 8/30/2006. SIGNED.
- Apprenticeship Program Standard (AB 2929 -Laird). Would have established basic guidelines for the approval or expansion of apprenticeship programs. Passed Senate Floor 26-14 on 8/29/2006; Passed Assembly Floor 47-29 on 8/30/2006. VETOED.
- Initiative Reform (AB 2946 Leno). Would have enacted critically important reforms of the initiative process in California, including banning "persignature" bounty payment to signature gatherers. Passed Senate Floor 21-13 on 8/30/2006; Passed Assembly Floor 47-30 on 8/31/2006. VETOED.
- 17. Digital Infrastructure and Video Competition Act of 2006 (AB 2987 - Nuñez). Levels the playing field for all players in the video communications market and ensures that the most vulnerable consumers are protected and good jobs are created. Passed Senate Floor 33-4 on 8/30/2006; Passed Assembly Floor 68-7 on 8/31/2006. SIGNED.
- Railroad Safety (AB 3023 Nuñez). Addresses several significant problems that affect public safety and the safety of those who work for the railroads. Passed Senate Floor 22-16 on 8/28/2006; Passed Assembly Floor 47-31 on 8/29/2006. SIGNED.

#### SENATE:

- Family Day Care Providers (SB 697 Kuehl). Would have allowed family child care providers to organize into unions for the purpose of negotiating terms and conditions of employment and reimbursement rates. Passed Assembly Floor 45-34 on 8/30/2006; Passed Senate Floor 24-15 on 8/31/2006. VETOED.
- 20. Video News Release Prohibition (SB 740 -Romero). Would have prohibited the use of public resources to create video news releases promoting proposed regulations prior to their adoption. Passed the Assembly Floor 47-31 on 8/21/2006; Passed Senate Floor 23-13 on 8/23/2006. VETOED.
- Permanently Disabled Worker Benefits (SB 815 -Perata). Would have increased the number of weeks of benefits for permanently disabled workers. Passed Assembly Floor 44-33 on 8/30/2006; Passed Senate Floor 23-14 on 8/31/2006. VETOED.
- 22. Universal Healthcare (SB 840 Kuehl). Would have covered every Californian with comprehensive health insurance and given them the ability to choose their own physician. Passed the Assembly Floor 45-33 on 8/28/2006; Passed Senate Floor 24-13 on 8/31/2006. VETOED.
- 23. **Paycheck Cashing Fees** (SB 1188 Florez). Would have prohibited banks from charging fees to cash paychecks drawn on accounts at their bank. Passed Senate Floor 23-14 on 5/11/2006. FAILED in Assembly Banking and Finance 1-5 on 6/26/2006.
- 24. **Hospital Lift Teams** (SB 1204 Perata). Would have required specified hospitals to implement a policy of replacing manual lifting of patients with powered patient transfer devices, lifting devices, or lift teams ("zero lift policy"). Health care workers lead the nation in back injury rates. Passed Assembly Floor 48-31 on 8/28/2006; Passed Senate Floor 24-14 on 8/31/2006. VETOED.
- 25. **Port Truck Driver Organizing** (SB 1213 Dunn). Would have allowed port truck drivers to form unions, engage in the collective negotiation of rates, and engage in binding arbitration of their disputes. Passed Senate Floor 23-13 on 5/11/2006; Passed Assembly Floor 47-28 on 8/17/2006. VETOED.

- 26. **Corporate Political Accountability** (SB 1354 Dunn). Would have required corporations to disclose political contributions to their shareholders. Passed Senate Floor 25-13 on 5/30/2006. FAILED 5-3 in Assembly Banking and Finance Committee on 6/26/2006.
- Car Wash Worker Protections (SB 1468 Alarcon). Will maintain crucial protections for car wash workers by extending the sunset date on the Car Wash Registry. Failed Assembly Floor 33-35 on 8/10/2006; Passed Assembly Floor 42-35 on 8/22/2006; Passed Senate Floor 22-14 on 8/23/2006. SIGNED.
- Economic Impact of Superstores (SB 1523 -Alarcon). Would have required a superstore retailer to provide cities and counties with an economic impact report, including wage and benefits data prior to approval. Passed Assembly Floor 46-33 on 8/28/2006; Passed Senate Floor 23-16 on 8/30/2006. VETOED.
- **COMMITTEE VOTES:**

#### **Assembly Labor Committee**

- 29. **Dismantle Prevailing Wage** (AB 2019 Cogdill). Would have lowered the wages and benefits of California's construction workers by rewriting decades of prevailing wage case law and changing the process of calculating prevailing wages. BAD BILL. FAILED Assembly Labor Committee 2-6 on 4/19/2006.
- Daily Overtime Changes (AB 2217 Villines).
   Would have weakened daily overtime protection for California's workers. BAD BILL. FAILED Assembly Labor Committee 2-6 on 4/19/2006.
- Workplace Posting (AB 2277 Villines). Would have allowed the Division of Labor Standards and Enforcement (DLSE) to weaken language that is included in labor law workplace postings. BAD BILL. FAILED Assembly Labor Committee 2-6 on 4/19/2006.

- Prevailing Wage Exclusion (AB 2331 Villines).
   Would have prevented prevailing wage from being paid on specified affordable housing projects. BAD BILL. FAILED Assembly Labor Committee 2-6 on 4/19/2006.
- Labor Union Reporting Requirement (AB 2349 -Maze). Would have diminished labor's political voice by imposing unnecessary new reporting requirements on labor organizations. BAD BILL. FAILED Assembly Labor Committee 2-6 on 3/29/2006.
- 34. Apprenticeship Program (AB 2660 La Suer). Would have deleted a vital measure of accountability that requires the Division of Apprenticeship Standards to determine the need for a new apprenticeship program before approving it. BAD BILL. FAILED Assembly Labor Committee 2-6 on 4/19/2006.

#### Senate Labor Committee

- 35. Workers' Compensation at Family Farms (AB 2493 Cogdill). Would have excluded any person from receiving workers' compensation insurance benefits who is employed without compensation by someone's family member. BAD BILL. FAILED Senate Labor Committee 2-3 on 6/28/2006.
- Daily Overtime Changes (SB 1254 Ackerman). Would have weakened daily overtime protection for California's workers. BAD BILL. FAILED Senate Labor Committee 1-3 on 4/26/2006.
- 37. Electrician Apprenticeships (SB 1365 Aanestad). Would have jeopardized the safety of tens of thousands of construction workers, as well as the public's health and safety, by expanding the number of trainees that can be supervised by a journeyman certified electrician from one to three. BAD BILL. FAILED Senate Labor Committee 1-3 on 5/10/2006.


